



Emergency Services

Emergency Food Distribution

Lighthouse continues to distribute food and other necessities through a home delivery system, at our food pantries in Pontiac and Clarkston, and at partner locations throughout the county. Lighthouse makes every effort to provide well-balanced food boxes packed with fresh produce, milk, bread, and pantry staples such as pasta, cereal, canned meats, peanut butter, jelly, soups, and beans. Between our partnership with Amazon Flex and our volunteer drivers, we completed 14,520 at-home deliveries in 2022.

In 2022, we served

21,503 households

with food throughout the entire county.

Homelessness Prevention

Preventing evictions protects families from the traumas of experiencing homelessness and aids them in more swiftly regaining stability.

Across all of our eviction prevention programs, Lighthouse assisted

1,856 households in preventing their eviction and maintaining their housing.

Emergency Shelter

Lighthouse was thrilled to open our permanent family emergency shelter in 2021. This new shelter provides the community with 18 units and 54 beds of emergency shelter dedicated to families. Of those who exited our shelter programs in 2022, 77.5% transitioned from shelter to housing.

Runaway & Homeless Youth Programs

In February 2023, Lighthouse assumed leadership of three runaway and homeless youth programs previously operated by Common Ground:
Sanctuary, A Step Forward, and Graduated Apartment Program (GAP).

Sanctuary is a short-term, safe shelter for youths ages 10-17 who have run away, are homeless, or are in an abusive, hostile, or intense situation at home.

A Step Forward is a safe and homelike transitional living shelter for homeless youth (ages 16-17). Designed for youth seeking self-sufficiency, this program also offers counseling, job training, career development, educational assistance, financial subsidies, and medical assistance.

The Graduated Apartment Program

(GAP) provides independent living services for youth ages 18-24 years old who are experiencing homelessness. GAP offers up to 24 months of housing, case management, counseling, and educational and employment support to help people develop a greater level of self-sufficiency, interpersonal skills and housing readiness.

These important programs serve

135 youth annually.

Stability Services

Rehousing Programs

Lighthouse implements a variety of housing programs that move households from homelessness to housing. Some programs offer longterm financial assistance for those experiencing domestic violence or those who have experienced chronic homelessness, and others assist households who are experiencing homelessness for the first time and need just a few months of assistance to regain stability.

Across all our housing programs in 2022, Lighthouse served **207 total households,** including **62 households** in our Rapid Re-Housing Program and **145 households** in our Medium-Long Term Housing Programs.


Hand^{UP}

Many of the needs households have are unique or not covered by existing grant and funding streams. Lighthouse helps households meet these needs through our flexible online fundraising platform, HandUp. Since inception, we have raised nearly \$4.5 million on HandUp to support projects and clients at Lighthouse. These funds have helped support our programs and helped over 1,000 clients meet their goals by providing funds for housing, transportation, education, medical expenses, and other basic needs.

Supportive Services

Our supportive services offer ongoing support to help households retain their housing and increase their overall stability. Individuals enrolled in our housing programs are provided with consistent in-home case management. Our team works together with our clients to establish service plans that are specific to the clients' needs, goals, and desires.

93% of clients that exited from Stability Service programs retained their housing and increased their self sufficiency in 2022.



Systems Change and Community Development

Affordable Housing Development

While it is critical that we meet the emergency needs of those experiencing poverty, to truly address multigenerational systemic poverty we must go beyond resolving household level crises. We must also provide long-term affordable housing options that provide families with the foundation needed to focus on long-term goals, achieve stability, and end intergenerational poverty. Tens of thousands of Oakland County households are rent burdened -- paying more than 30% of their pretax income on rent. Lighthouse addresses this need through a multifaceted strategy that currently includes building and developing new affordable housing and acquiring and renovating existing affordable housing.

Through these efforts, in 2021 Lighthouse partnered with the Pontiac Housing Commission to secure \$40.3M to rehab 234 affordable housing units at Carriage Circle. This important project will be completed in Spring 2023 and will greatly improve the quality of life of the over 300 residents.

Lighthouse is also proud to operate Coolidge Place, a 64-unit affordable housing complex in Oak Park, as well as Beacon Square, Beacon Townhouses, Whittemore Place, and scattered-sight single family homes in the Unity Park neighborhood, which provide a total of 65 affordable housing units.

We're also committed to efforts around homeownership and increasing the number of homeowners, especially within the City of Pontiac. In 2022, we reevaluated two rental properties and were able to move forward with providing two new homeownership opportunities, while creating a down payment assistance program, which you'll hear more about soon!

The Lighthouse Campus

Lighthouse is pursuing plans to redevelop its headquarters at 46156 Woodward Ave. in Pontiac into a strong, centralized base of operations, and a "one stop shop" for Oakland County residents in need. Pending site plan approval, construction for the project could begin in 2024 and be complete by 2025.

The Lighthouse Campus will include elements to combat homelessness, address food insecurity, and provide supportive services, and will include:

- A Housing Opportunity Center, with interim housing in private quarters and supportive services, where families in need of shelter can reside safely as they work to obtain stable housing.
- **A Social Supermarket**, where residents can shop without cost for the items they need, while connecting with a social worker who can help them access additional stabilization services.
- **3** An Economic Opportunity Center, where anyone in need can connect to social workers, access computers, receive financial and employment coaching, and more.
- Multiple community spaces, where guests can gather to eat and connect, and community/congregation partners can host activities, provide support and create opportunities for volunteer engagement.



Shine Your Light for the Holidays

Lighthouse aims to provide holiday cheer to local families in need throughout the holiday season. Our Thanksgiving and Adopta-Family programs bring a little help and hope to thousands of individuals each year. These programs are made possible because of thousands of supporters who make donations, host food drives, and adopt families in need.

THANKSGIVING:

In 2022, Lighthouse was able to provide a full Thanksgiving meal to 2,334 local families in need thanks to the incredible support we received from businesses, schools, congregations, community groups, and individuals! There were 101 groups that helped collect and donate 49,262 pounds of food. Overall, 292 volunteers donated over 800 hours of their time to sort donations, pack food boxes, and help distribute food. We are truly in awe of how much support we received this year and thankful so many families had a meal this Thanksgiving because of your generosity!



ADOPT-A-FAMILY:

In 2022, 618 local families in need were adopted for the holidays thanks to the generosity of over 300 local individuals, families, and organizations. Special thanks to the 353 volunteers who gave 1,400 hours of time to this important program. We are so thankful to help bring joy to so many men, women, and children during this special season.






